CHARTER MEMBERSHIP

Past due bills will accrue a one and one-half percent (1½%) service charge each month from the date of the statement until paid in full. The undersigned further agrees to pay all reasonable attorneys' fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts. . Annual Club Dues are currently \$1,400 for the calendar year 2007 and are generally billed in December for the calendar year immediately following. New members are billed on a pro rata basis at the time they close on the membership purchase.

No membership certificate shall be issued until the undersigned has been approved for membership and the membership contribution required is paid in full.
